


munity of practice (CoP) to support the application of the National Standards for Culturally and Linguistically Appropriate Services¹ (National CLAS Standards) into their community-based system of care for opioid use disorder. As the COVID-19 pandemic escalated and disrupted service delivery, community leaders utilized the existing CoP infrastructure to identify, share, and co-create innovative strategies to reach and serve people experiencing multiple and intersecting disadvantages while infusing the National CLAS Standards into the response efforts. #### National Standards for Culturally and Linguistically Appropriate Services (CLAS) in Health and Health Care

The National CLAS Standards are intended to advance health equity, improve quality, and help eliminate health care disparities by establishing a blueprint for health and health care organizations to:

#### **Key Project Outcomes**

- Developing a Training Academy for Chemical Dependency Counselor Assistant Certification & continuing education: 66 have completed TA & 32 currently enrolled; 2 trainings remaining
- Hosting Peer Support Certification Trainings for the 40-hours of training required for Certification for Peer Support in OH: 137 have participated in training
- Implementing online training for providers and staff to maximize reimbursement through coding and billing: 3 medical offices trained, with 15 individual completing the training

#### **Key Works in Progress**


- Assessing the impact of stigma related to substance use disorder and mental health







The Tristate Trauma Network in partnership with Finding Hope Consulting, LLC is hosting a virtual offering of the <u>Trauma Responsive Care Certification Series</u> starting Sept. 22 and running through March 16, 2022. There are eight days of training: Sept. 22, Oct. 4, Oct. 13, Nov. 17, Dec. 13, Jan. 19, Feb. 9 and March 16. The series is an approved for the *OH Trauma-Informed Care Certificate* and also lead to Trauma-Responsive Care Certification through Tristate Trauma Network. Cost, which includes registration and certification application, is \$750. Participates may also choose to attend a two-day foundational training on Sept. 22 and Oct. 4 for \$175.
